The aim of this study was to report our 12-year experience in the management of patients with multilocular ameloblastoma (MA).

We analyzed the medical records of 8 patients with 9 MA lesions, diagnosed and treated at our institution between March 2002 and March 2014. All patients were treated with initial surgical approach of the lesion, and then follow-up was performed. There were 4 male and 4 female patients. In all patients, the lesions were completely removed, except for 1 case with initial incomplete removal. Eight of 9 lesions were located in the mandible, 3 in the maxilla, and 2 in the mandible and maxilla. For the lesions located in the mandible, the mean time to recurrence was 11.3 months (range: 4-22 months), and the mean duration of follow-up was 12.3 months (range: 6-30 months). All recurrent lesions were again completely removed. There were no postoperative complications in any patient.
